to convene the meeting of the Unsecured Creditors of Bharat Biotech International Limited (hereinafter referred to as the “**Applicant Company**”) summoned by Notice dated 09.12.2025, dispatched to them on 09.12.2025, by way of courier, to all 572 (Five Hundred and Seventy Two) Unsecured Creditors of the Company whose names are appearing in the Certificate given by the Independent Chartered Accountant dated 30.09.2025 and by advertisement dated 10.12.2025, published in Business Standard (English Version), Hyderabad Version, and dated 11.12.2025, published in Nava Telangana (Telugu Version), and held on Monday, the 12.01.2026, at 11:00 A.M (IST) at Survey No. 230, 231 & 235, Genome Valley, Turakapally Village, Shamirpet Mandal, Medchal Malkajgiri District, Hyderabad 500078, Telangana, India, do hereby report to this Hon’ble Tribunal as follows:

2. The said meeting was attended by 106 (One Hundred and Six) Unsecured Creditors in person / through Proxy / authorized representatives, to whom the Applicant Company owes an amount of Rs.80,16,09,823/- (Rupees Eighty Crores Sixteen Lakhs Nine Thousand Eight Hundred and Twenty Three only) representing 74.52% in value of the total value of debts due by the Applicant Company to its Unsecured Creditors as on the Cut-off date 30.09.2025.
3. The Scheme of Arrangement (Demerger) for Demerger, transfer and vesting of the treasury business of the Demerged Company more specifically described in Schedule I (“Demerged Undertaking 1”) and the real estate business of the Demerged Company that is more specifically described in Schedule II (“Demerged Undertaking 2”) from Bharat Biotech International Limited (“Demerged Company”) to Ellask Tracon Private Limited (Resulting Company-1) and Ellacriety Infratech Private Limited (Resulting Company-2) was taken as read with the permission of the Unsecured Creditors present at the meeting and explained briefly at the meeting and the question submitted to the said meeting was whether the Unsecured Creditors of the Applicant Company approve the Scheme as submitted to the meeting and agree thereto ?
4. The Unsecured Creditors of the Applicant Company were of the opinion that the Scheme of Arrangement (Demerger) for Demerger, transfer and vesting of the treasury business of the Demerged Company more specifically described in Schedule I (“Demerged Undertaking 1”) and the real estate business of the Demerged Company that is more specifically described in Schedule II (“Demerged Undertaking 2”) from Bharat Biotech International Limited (“Demerged Company”) to Ellask Tracon Private Limited (Resulting Company-1) and Ellacriety Infratech Private Limited (Resulting Company-2) should be approved as

submitted to the meeting without any modifications and have agreed to and passed the following resolution unanimously:

“RESOLVED pursuant to the provisions of section 230 to 232 - Chapter XV of the Companies Act, 2013, and all other applicable provisions, if any of the said Act, (including any statutory modification(s) or re-enactment thereof, for the time being in force), and the necessary clauses in the Object Clause of the Company’s Memorandum of Association and subject to the approval by the National Company Law Tribunal (NCLT) at Hyderabad and further subject to the consents, approvals and permissions being obtained from appropriate authorities to the extent applicable or necessary, the Scheme of Arrangement (Demerger) for Demerger, transfer and vesting of the treasury business of the Demerged Company more specifically described in Schedule I (“Demerged Undertaking 1”) and the real estate business of the Demerged Company that is more specifically described in Schedule II (“Demerged Undertaking 2”) from Bharat Biotech International Limited (“Demerged Company”) to Ellask Tracon Private Limited (Resulting Company-1) and Ellacrity Infratech Private Limited (Resulting Company -2) respectively placed before this meeting, be and is hereby approved”.

“RESOLVED FURTHER THAT Dr. Krishna Murthy Ella, Executive Chairman, Dr. Suchitra Ella Managing Director of the Company, Mr. Sai D Prasad and Dr. V. Krishna Mohan, Whole-time Directors of the Company, Mr. Srinivas Tadepally, Chief Financial Officer of the Company, Ms. Y.K. Priyadarshini, Company Secretary (collectively, “Authorised Persons”) be and are hereby authorized to do and perform all such acts, deeds, matters and things, as may be considered requisite, desirable, appropriate or necessary to give effect to this resolution and effectively implement the arrangement embodied in the Scheme and to accept such modification, amendment, limitations and conditions, if any which may be required and/or imposed by the Ministry and or any other authorities while sanctioning the Scheme or by any authority under law, or as may be required for the purpose of resolving any doubt or difficulties that may arise or meaning or interpretation of the Scheme or implementation thereof or in any matter whatsoever connected therewith, including passing of such accounting entries and /or making such adjustments in the books of accounts as considered necessary in giving effect to the Scheme, as the Board may deem fit and proper.”

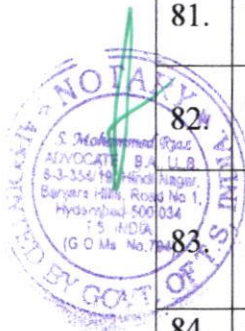

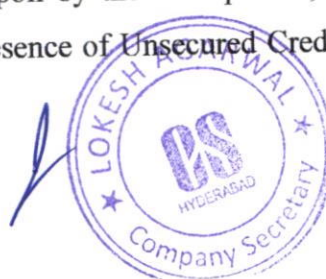

I hereby submit my report as follows:

1. Pursuant to the directions of the Hon'ble Tribunal dated 03rd December, 2025 in CA.(CAA)NO.42/230/HDB/2025, the Notice, dated 09th December 2025, of the Tribunal Convened Meeting of the Unsecured Creditors of the Company, specifying the day, date, time and venue of the meeting, together with a copy of the Scheme of Arrangement between Bharat Biotech International Limited (Demerged Company) and Ellask Tracon Private Limited (Resulting Company-1) and Ellacrity Infratech Private Limited (Resulting Company-2) and their respective Shareholders and Creditors ('the Scheme'), Explanatory Statement, form of proxy and other necessary information and documents as required under applicable provisions of the Companies Act, 2013, read with relevant rules made thereunder, was dispatched by the Company by way of Courier to 572 (Five Hundred and Seventy Two) Unsecured Creditors as at 30th September, 2025 (Cut-off date).
2. Further an advertisement with regard to the day, date, time and venue of the meeting of the Tribunal Convened Meeting of the Unsecured Creditors of the Company was carried out in Business Standard, English Daily on 10.12.2025 and in Nava Telangana, Telugu Daily, on 11.12.2025.
3. I was provided with the List of Unsecured Creditors as on the Cut-off date, Register of Attendance, the Register of Proxy and the Proxy forms received by the Company. 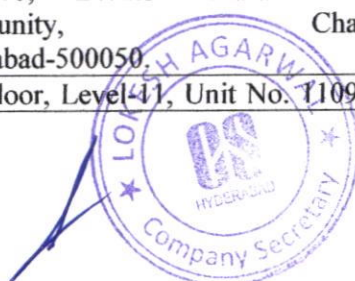
